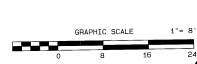

BUILDING TWO SECOND FLOOR

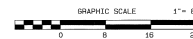

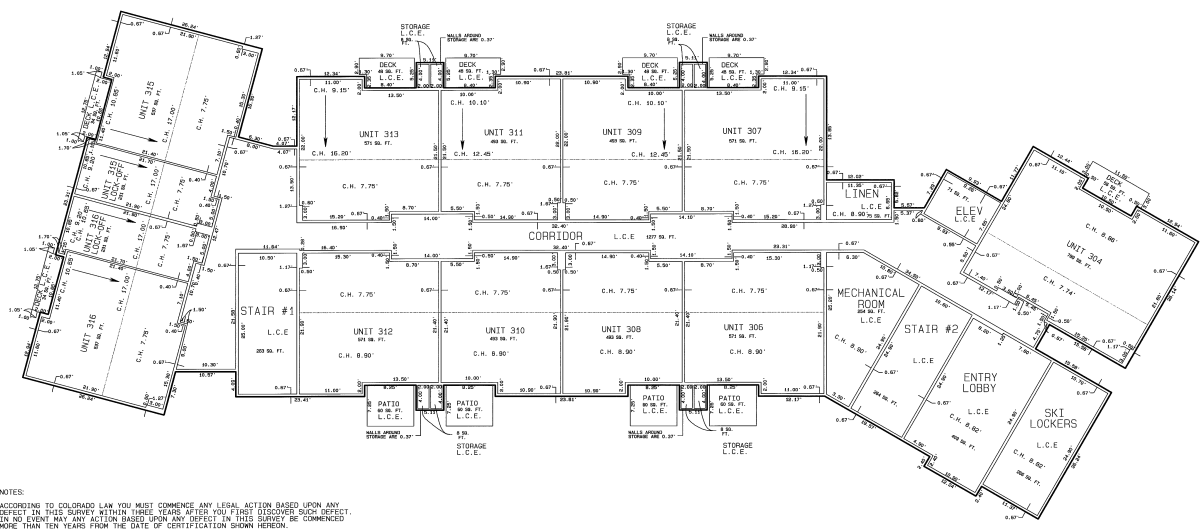

AMENDED MAP OF BUILDING TWO OF THE LODGE AT MOUNTAIN VILLAGE A CONDOMINIUM PHASE ONE

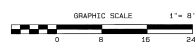

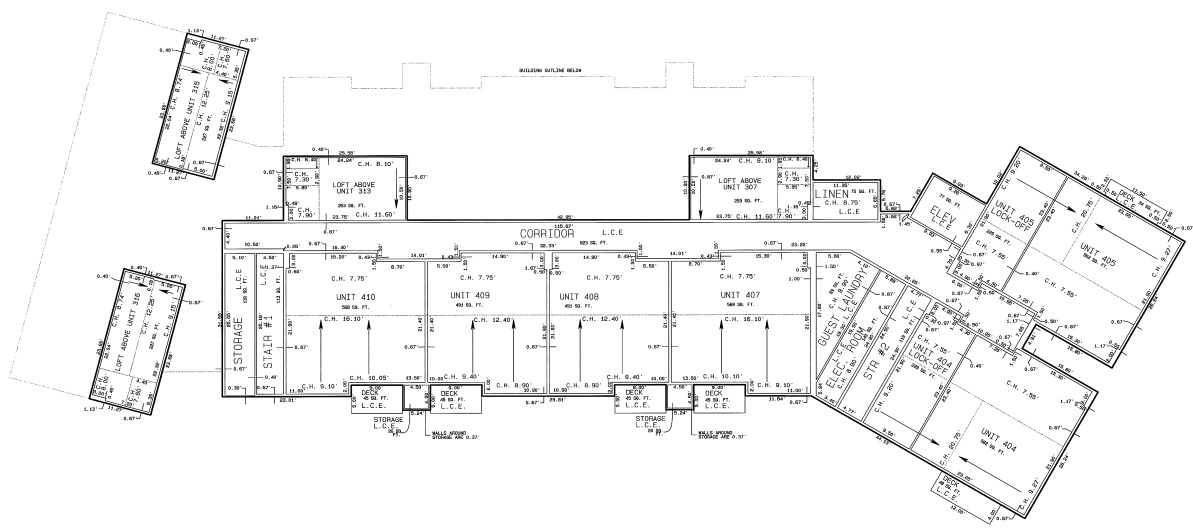

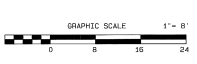

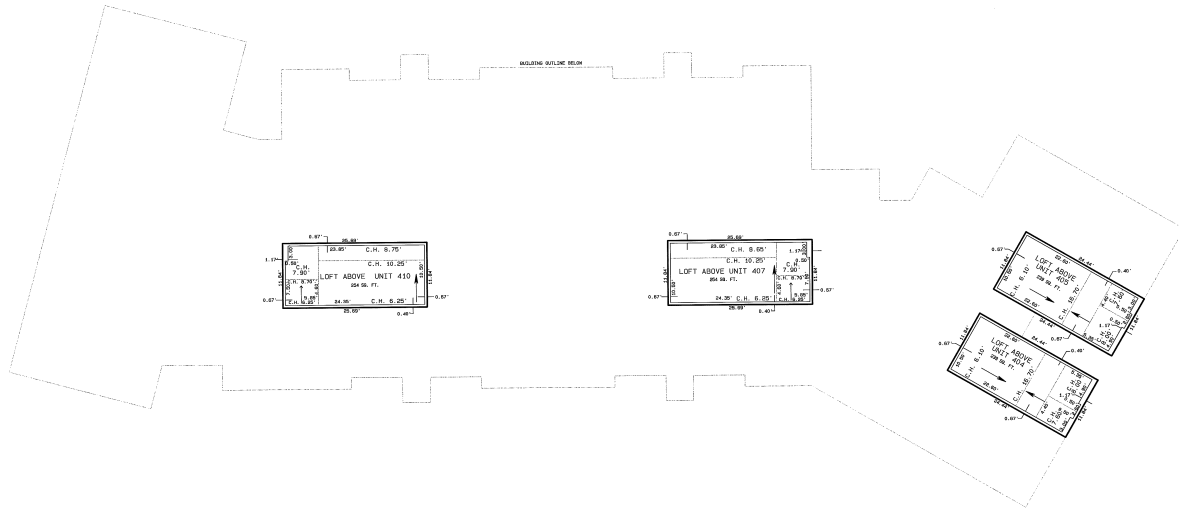

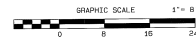

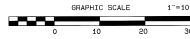
